

## 1. Introduction

Black Void Studios ("**Black Void Studios**", "**we**," "**us**") believes that your privacy is very important and therefore we are committed to protecting and respecting your privacy. We collect, store, use, and manage the information, including personal information, as a data controller in accordance with applicable laws and in order to provide and develop our mobile game applications and websites (together "**Services**").

All information collected within the Service is stored on public cloud servers like Amazon Web Services, Microsoft Azure and Google Cloud Platform located in the United States or other countries. In this regard, we take steps to ensure adequate safeguards are in place to enable use and disclosure of information about you, including personal information, as described in this Privacy Policy.

All our Services are governed by this privacy policy ("**Privacy Policy**") together with our Terms of Use available at <http://www.alphabunker.ca> and any other documents referred to in it. By using or accessing a Service you give consent to the processing, use and disclosure of your data. Please do not install, access or use the Services if you do not agree to this Privacy Policy.

We also reserve the right to modify this Privacy Policy. Your continued use of Services will signify your acceptance of the changes to this Privacy Policy.

## 2. Information We May Collect From You

Information we may collect through your use of our Services include:

- **Registration and Account Information:** When you register with the Service, we automatically collect your operating system and device name, Internet Protocol (IP) address, access time, language. A unique username is also generated to you within the Service;
- **Profile information of your social media (SN) account:** When you download our mobile game application through SN you may volunteer information (such as profile photo, gender, age or birthday, links to profiles on other social networking websites)
- **Subscribing to our Mailing List:** If you subscribe to our mailing list, we will collect you first name, last name and email address;

- **Publicly Shared Information:** Data that you share via the Service, such as postings in forums, chats, message boards and blogs, and other interactive features of the Service, your public profile, and your friends list in the Service;
- **Sweepstakes/Promotions:** Data that you may provide in order to participate in sweepstakes and promotions. We use this information to notify winners and award prizes, to monitor traffic or personalize the Service.
- **Game data:** As you use our Services, we collect data about all of your interactions with the Service and other users (such as other players inside the game).
- **When you contact our support:** If you contact us, we collect your name and email address. A record of your correspondence with us may also be kept.
- **Employment information:** When you apply for a job, you may volunteer information such as resume, name, email address and phone number. We use this information to contact you regarding setting up an interview or to determine if you are qualified for the position in which you applied.
- **General Location data:** We collect your location information for the purpose of providing you with the correct version of the application, geoblocking as necessary, fraud prevention and for targeted marketing. We collect this information each time you start using the Service (i.e. when you start a new session on our game) by looking at the information provided with the connection of the Service on your device.
- **Location data from a location based game:** In case the Service contains a location-based game, in addition to the general location data described above, we collect and store information about your location when you use the Service and take game actions that use the location services made available through your device's mobile operating system, which makes use of cell tower triangulation, Wi-Fi triangulation, and/or GPS. You understand and agree that by using our Services you will be transmitting your device location to us, and that location, along with your player name, will be shared publicly with other users through our Services when you take an in-game action. We may also use location information to improve and personalize our Services for you.

### 3. Analytics, tracking and other Collection Practices

### *Our Own Analytics*

Black Void Studios uses your information to perform its own analytics and to enable analytics provided by third parties. We use analytical information for supporting business analysis and operations, business intelligence, product development, improving products and services, personalizing content, providing advertising, and making recommendations. We use technologies such as cookies, beacons, scripts, and tags to identify your device and to “remember” things about your visit, such as your preferences or a user name and password. Information stored in a cookie may be linked to your personal information, such as your user ID, for purposes such as improving the quality of our Services, tailoring recommendations to your interests, and making the Service easier to use. You can disable cookies at any time, although you may not be able to access or use features of the Service.

### *Third Party Tracking and Analytics*

Our Services may contain third party tracking and data collection and analytics tools from our service providers, such as Unity, which help us analyze and improve our Service.
